

In the April 23rd issue of the Chicago Tribune, Fairfax Family Practice Centers (FFPCS), was featured as part of an article focusing on Patient Centered Medical Homes (PCMH). The 12 FFPCS offices were referred to as leading the forefront of the growing trend of PCMH – organizing all facets of a patient's care, performing a wide range of medical services, and offering emotional as well as clinical support. The author hailed patient centered medical homes as a means to improve quality of care provided to the community, provide cost saving, improve population-based health outcomes, and reduce excessive services. FFPCS has been a leader in ACORN research for nearly 20 years. The offices participate in both the My Preventive Care (MPC) and Informed Decision Making (IDM)

Practitioners in many areas of Virginia have little or no access to the high quality medical research without incurring lofty expenses, while Medicine and Population Health received the 2014 Society of Teachers of Family Medicine (STFM) Best Research Paper of the Year award for the paper titled "Interactive Preventive Health Record to Enhance Delivery of Recommended Care: A Randomized Trial." This study was done with ACORN practices located primarily in Northern Virginia and tested the effectiveness of an interactive preventive health record (IPHR) linking patients to their clinicians' record. ICD 10 Delay Brief

Congress passed legislation on April 1st to postpone the conversion to ICD 10 for a year, making the date for compliance October 1, 2015. As part of the larger bill, Protecting Access to Medicare Act of 2014 (PAMA) which some have called the "Doc Fix," this delay is in response to the lack of agreement on the repair of the Sustainable Growth Rate (SGR) formula and would prevent a 24% cut to physician Medicare reimbursement.

The postponement provides a temporary relief for clinicians, especially those who are not prepared for the expensive change that is expected with this conversion. PAMA does not address the need to reform physician payment. This is likely the reason why stakeholders, including the American Hospital Association, American Health Information Management Association, and others have been lobbying to vote down the bill.

ACORN Current Study Updates

Redesigning Diabetes Work Association (SFMA) had the fortune to participate in a clinical workshop hosted by a VCU affiliated family medicine residency.

SFMA members expressed interest in mental and behavioral health within the context of family medicine. Dr. Richard Hoffman, Program Director, Chesterfield Family Medicine Residency, readily responded. In consultation with Nancy MacConnachie, Ph.D, Licensed Clinical Psychologist, Ms. Amy Daubenspeck, Residency Coordinator, the faculty and residents, the residency program hosted an amazing learning experience for the medical students. Following a brief overview, students rotated through exam rooms in pairs to interview simulated patients. Faculty and residents served as patients with scenarios drawn from real patient encounters.

Sample encounters included a middle aged woman with depression, a man with OCD, a woman with anxiety issues, and an adolescent with a presenting problem that appeared to be behavioral in

A member of the MyPreventiveCare Patient Advisory Board, Joe McDonald, was interviewed about his perspectives as a patient of FFPCS for the article. Joe highlighted that using FFPCS' patient health

record (MyPreventiveCare) allows everything to be "right at my fingertips." He receives alerts for colonoscopies and other screenings through MPC. At the core of these successful tools, Joe emphasizes the importance of his physician taking the time to get to know him and the one on one personal relationship he has with his doctor. In his role on the MyPreventiveCare Patient Advisory Board, Joe and eleven other patient members help to direct the design of MyPreventiveCare and the research supporting its ongoing development.

Redesigning Diabetes Work Processes for Population-Based Primary Care

Short Study Title: Supporting Practice Adoption of Registry Based Care or SPARC

Purpose: To evaluate the effectiveness of a multi-faceted organizational change intervention focused on diabetes registry adoption.

Update: Pilot testing of the tablet-based chart audit tool and active recruitment of practices in the Richmond metro area for study participation is ongoing.

Implementing Personal Health Records to Promote Evidence-Based Cancer Screening

Purpose: To learn how practices engage patients to provide tailored, patient centered, preventive care recommendations, educational materials, resources and tools to inform and activate patients.

Update: Finalization of study site recruitment is occurring along with ongoing technical integration of MyPreventiveCare (MPC) into Cerner and Epic. Assembly of the patient and clinician stakeholders to assist guidance of the MPC advances and study design continues in addition to content updates in MPC.

An Interactive Preventive Health Record to Increase Colorectal Cancer Screening

Short study title: My Colorectal Cancer Screening or My CRCS+

Purpose: To develop an effective, interactive, web-based tailored decision aid tool within a personal health record that promotes informed decisions and increase colorectal cancer screening.

Update: Formative research continues to learn what patients deem important for tailored intervention materials focused on colorectal cancer screening.

Understanding Patient Preferences for Informed Decision Making

Short study title: An Informed Decision Making Module for Cancer Prevention Screenings or Informed Decision Making (IDM)

Purpose: To explore patients' preferred approach to cancer screening using an interactive website about informed decision-making preferences, study the assistance offered by clinicians, its congruence with patient preferences, and effect of website exposure on conversation and decision outcomes. Update: In the final stages of completing Phase II of fielding the IDM survey. Phase III will begin on May 15 with all eligible patients to receive an email invitation for this module. Continued progress is being made on audio-recording office visits. More than 300 patients have currently completed the survey.

What Do Vulnerable Patients Want in Publically Available Health Care Consumer Reports? Short Study title: Health Care Consumer Reports

Purpose: To make recommendations for consumer reports for Type 2 Diabetes by engaging vulnerable populations' perceptions of their needs. Currently in the analysis phase of the study.

Update: Vulnerable patients with type 2 diabetes have been found to desire basic information about diabetes, its self-management and especially diet. The comparative physician profiles in consumer reports are less of interest as most of these patients like their current physicians and are not interested in finding another physician.
